

Official Rules

No Purchase Necessary to Participate in Contest

ELIGIBILITY: The Jazz at Lincoln Center/Jamaica Jazz & Blues Festival Contest (the "Contest") is open to all legal permanent residents of the United States (the "Eligibility Area") who are eighteen (18) years of age or older. The Contest is void in Puerto Rico, U.S. territories and possessions outside of the U.S., and where otherwise prohibited by federal, state, municipal or local law. All federal, state, local, and municipal laws and regulations apply. Employees and their immediate families, including household members, their respective parents, affiliates, subsidiaries, divisions and advertising and promotion agencies of Jazz at Lincoln Center, Inc. (the "Sponsor"), as well as all promotional partners, are not eligible to participate in the Contest.

HOW TO ENTER: No purchase necessary. Contest is open from November 24, 2008 to January 7, 2009 ("Entry Period"). You can only enter this Contest by responding to the questions on the Entry Form, entering your email address and clicking the "Submit" button. Only one entry per email address. Entries must be made from within the Eligibility Area and must be received by Sponsor within the Entry Period. Entries that do not comply with these Official Rules in all respects are ineligible and void.

Sponsor at its sole discretion may determine any entry invalid and ineligible for any reason whatsoever.

CONDITIONS OF ENTRY: You must be the Registered and Authorized Holder of the email Account through which the entry is made. For purposes of this Contest, a "Registered and Authorized Holder of the email account" is defined as the natural person who is assigned to an email address by an internet service provider, online service provider or other entity (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the secondary level domain name associated with the submitted email address. Entries must be made by an individual from a single computer and may not be made by proxy, or electronic means such as script, bot, macro or any other similar software or program. All entries become the property of Sponsor. By participating, entrants agree to these Official Rules, including all eligibility requirements. By entering this Contest, you consent to Sponsor's use of your name and likeness for promotional purposes in connection with the sweepstakes, without additional compensation, except where prohibited by law. PRIZE: One Grand Prize will be awarded. Grand prize consists of one 4-day/3-night trip for two to the 2009 Jamaica Jazz & Blues Festival in Montego Bay, Jamaica. Prize includes roundtrip airfare for two from New York's JFK airport to Montego Bay, Jamaica via Air Jamaica, three-night all-inclusive accommodations at the Ritz Carlton [Golf Resort & Spa, Rose Hall Jamaica](#), and two tickets to each day of the three-day Jamaica Jazz & Blues Festival. Travel MUST commence on January 22, 2009 and end on January 25, 2009. No other dates will be honored for travel. If winner cannot travel on these dates, they must forfeit the prize and an alternate winner may be selected. Certain restrictions, conditions and limitations may apply. Sponsor is not responsible for lost or stolen prizes. No prize substitution or assignment or transfer of prizes is permitted, except by Sponsor, in which case a prize of equal or greater value will be awarded. In no event will more than the stated number of prizes be awarded.

ODDS OF WINNING: The odds of winning the stated prize depends upon the number of eligible entries received during the Entry Period.

DRAWING: Potential Prize winner will be selected on or about January 8, 2009 by a random drawing from among all eligible entries received during the Entry Period. Drawing will be conducted by Sponsor, whose decision is final with respect to all aspects of the Contest.

NOTIFICATION: Potential winner will be notified by email and/or by telephone. Potential winner will be given 3 days from the time the email notification is sent or telephone call made to respond to claim the prize or an alternate winner may be selected. As a condition of awarding the prize, the potential winner is required to sign an affidavit of eligibility/publicity and liability release, and return it properly executed, within three (3) days from the date the potential prize winner responds to claim the prize concerned. If a prize notification is returned as undeliverable or a potential winner fails to return the affidavit and release as specified, that potential winner will be disqualified and an alternate winner may be selected at Sponsor's sole discretion.

If, in Sponsor's sole opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of this Contest, any violation of these Official Rules, or if technical difficulties compromise the integrity of the Contest, Sponsor reserves the right to terminate the Contest and conduct a random drawing to award the prize using all entries received during the Entry Period.
